## COURSE SYLLABUS

### 1. COURSE GOALS

The main purpose is to introduce students to Criminal Law as one of the professional disciplines necessary for mastering legal interpreting skills. This course offers an introduction to the basic concepts of Criminal Law as well as methods of interpreting analysis of texts pertaining to the given legal domain. The content of the course is designed to familiarize the students with those concepts and analytical tools they may require for translation practice of relevant legal documents. In addition, it attempts to provide an overview of the field that enables students to seek answers for further questions about administrative law and to start formulating and pursuing their own research interests in legal language domain.

### 2. REQUIREMENTS FOR LEARNING OUTCOMES

- can identify effective strategies of translation suitable for legal texts and use them creatively for his/her own translation of written or oral texts
- can conduct research and make presentations on topics related to Criminal Law
- can create and edit professional texts within Criminal Law
- masters bilingual legal information processing skills
- masters skills of translating texts in the relevant branch of law.

### 3. COURSE IN HIGHER EDUCATION PROGRAMME STRUCTURE

The course refers to the variable component of (B1) block of the higher educational programme curriculum. It is taught in English, the students are expected to know English at level B2-C1 to follow explanations, take notes, and ask questions, as well as provide the answers for overall course study related activities in English.

Students are expected to know Criminal Law key concepts and theories.

### *Seminars*

The research case activities aim to develop critical thinking skills in the field of current bilingual legal texts that are offered for practitioners in the field of criminal law branches. The activities include critical analysis of current variants of translation versions of a Russian Code text into English. Concrete materials for individual research case are expected to be agreed among the group and the teacher to fit the students' individual professional needs and research purposes.

The course is designed to provide students with no less than 30% of its content to be taught through interactive forms in the classroom and through cloud-based group discussion of translation products and their quality.
