Programme of Higher Education (the "Programme") Description.

General Characteristics

1.1. Objective of the Programme.

The Programme is designed to teach highly skilled specialists in journalism, capable of taking into account scientific and research expertise and apply their knowledge and skills in their future professional activities. The objective of the Programme is to produce original scientific research contributing to the generation, expansion and development of the scientific knowledge as well as the formation and development of the students' competences in accordance with the requirements of the Standards of Higher Education of Peoples' Friendship University of Russia and the Federal State Standards of Higher Education in the appropriate area.

1.2. Main Information.

The target educational level of the Programme is constituted by the preparation of researchers and faculty (post-graduate studies). It is a full time programme designed for three years, or four years, if implemented by correspondence. The graduates are taught to conduct scientific research in journalism and mass communication and to provide higher education in the appropriate area of knowledge.

1.3. Principles of the Programme Implementation.

The Programme is based on the module principle.

1.4. The Programme from the Perspective of Demand of the Labour Market.

The Programme is designed to teach highly skilled researchers and faculty members as well as specialists capable of dealing with different types of texts. Those who complete their postgraduate studies within the framework of Programme 10.01.10 **Journalism/42.06.01 Mass Communication and Information and Library Science** are recruited in the areas of education translation, mass media, public relations and other spheres of activities. The graduates can carry out journalistic and other professional activity, covering such urgent problems as formation of image of the country abroad (country branding), efficiency of mass communication among different countries and peoples, information policy in business communications, convergent processes in a modern media sphere etc., to work as correspondents, observers, commentators, editors, editors-translators, the senior editors, etc.

1.5. Entry Requirements.

A candidate wishing to follow the Programme is expected to have higher education (master's degree), usually in journalism or public relations, have scientific publications in Russian and/or foreign journals, or a synopsis of research in the selected area. The list of entry exams complies with the requirements for those wishing to follow Programme 42.06.01 Mass Communication and Information and Library Science and comprises philosophy, foreign language and special discipline.

1.6. Graduate's Professional Activity:

The main educational programme designed for training highly skilled specialists (postgraduate studies) 42.06.01 Mass Communication and Information and Library Science is developed in accordance with the standard of higher education of Peoples' Friendship University of Russia.

1.6.1 Professional areas, where the Programme graduates will be involved, comprise mass media (newspapers, magazines, television, broadcasting, news agencies, internet mass-media), mass communication (new media, advertising and public relations), publishing houses and

information and library systems, and also the research and educational organizations in this sphere.

1.6.2 Objects of professional activities of the Programme graduates are various types of information, reflecting practices connected with functioning of mass media, mass communication, publishing houses and information and library systems and results of scientific research in the chosen sphere.

1.6.3 Types of Professional Activity.

The Programme graduate is trained for scientific and research activities in the field of journalism, for university teaching as well.

1.6.4 Objectives of Professional Activity.

The graduate's professional activities comprise scientific research in the selected sphere, working in professional scientific and research teams on development of urgent topics in the field of modern journalism, preparation of scientific projects in the field of journalism, including filing applications for grants, independent preparation of scientific publications in competitive Russian and foreign journals as well as teaching seminars and lectures at universities in the appropriate domains.

1.7. Competences to be Developed upon Completion of the Programme.

The graduate is expected to master the following universal competences, general professional competences and professional competences:
