1. GOAL OF DISCIPLINE MASTERING

The discipline "History of Russia" is included in the bachelor's program "Data Engineering and Space Systems Control" in the direction of 27.03.04 "Control in Technical Systems" and is studied in the 1st semester of the 1st year.
