1. EDUCATIONAL PROGRAMME GOAL (MISSION)

The purpose of «international economic relations» program is to train competent, competitive and highly qualified international economists capable of working in large Russian and international companies operating in Russia and abroad in the constantly changing conditions of the global economy and the formation of a new world economic order.

2. EDUCATIONAL PROGRAMME RELEVANCE, SPECIFICITY, AND UNIQUENESS

At the present stage of development of the world economy, there is not a single company, enterprise, bank, etc. that would not be engaged in foreign economic activity. In the era of globalization, international economic relations permeate our entire lives.

Graduates of the bachelor's degree of the profile "International Economic Relations and Foreign Economic Activity" possess the necessary knowledge and skills to conduct professional activities in the field of international trade in goods and services, international finance, international monetary and credit relations, international trade in intellectual property, international settlements and investment activities.

The program is designed for those who want to apply their knowledge in the field of economics at an international level.

Economist in sphere of international economic relations is a very conditional name that unites several professions. In some organizations, a graduate can be engaged in customs declaration of goods, in another - to look for partners abroad and conclude contracts with them, in the third - to analyze markets, consult, minimize financial risks under foreign trade contracts, engage in international procurement of goods and services, international settlements, drawing up schemes for conducting international business, optimizing taxation of international companies, attracting international financial resources, trading in the stock market, formation and expansion of the client base abroad, etc.

The profession of an international economist has always been and remains prestigious, elite and highly paid.

The program is focused on training specialists capable of defending the national economic interests both in their own country and abroad.
