

1. PURPOSE OF THE GRADUATE PROGRAM

The goal of the postgraduate program is to prepare and defend a dissertation for the degree of Candidate of Sciences in the scientific specialty 5.2.4 Finance .

The educational goal is to contribute to the formation in the graduate of humanitarian and social knowledge, skills and abilities necessary to solve the problems of professional activity, to ensure control over the level of mastery of competencies, giving him the opportunity to choose directions for the development and improvement of personal and professional qualities, increasing the role and significance of domestic education in all over the world.

The educational goal is to cultivate a sense of patriotism, to promote the formation of socially responsible behavior in society in the graduate, understanding and acceptance of social and ethical norms, and the ability to work in a team.

The developmental goal is to contribute to the formation of a harmonious personality, the development of the intellectual sphere, the disclosure of the student's versatile creative capabilities, the formation of a system of values, needs, and aspirations in building a successful career.

The results of mastering the postgraduate program are the completion by the postgraduate student of the educational and scientific components provided for by the curriculum; successful passing of candidate exams and defense of a dissertation for the degree of candidate of science in a given scientific specialty.

2. BRIEF PROGRAM SUMMARY

The educational program is the third stage of higher education. While studying in full-time graduate school, a graduate student acquires the skills of research work, teaching practice, preparation and defense of a dissertation for the degree of Candidate of Economic Sciences in specialty 5.2.4 Finance. The program involves training and research in the following areas: financial system, its structure, dynamics and development trends; modern concepts and theories of finance and their use in the activities of financial institutions; financial institutions: theory, methodology, patterns of development and improvement of management, tax regulation, conceptual foundations, priorities of tax policy and the main directions of reforming the modern Russian tax system, the basis for constructing a consolidated financial balance of the national economy and its use in developing the financial policy of the state., investment financing processes, fiscal policy, mechanisms and instruments of government borrowing in the domestic and foreign financial markets; changes in the regime for lending to the budget deficit of the Central Bank of the Russian Federation, the impact of the formation of public debt on the development of credit relations and the rise of the real sector, corporate finance, industry finance, financial and tax risk management, sources of financing for business entities, optimization of capital structure, financial mechanism of reproduction, circulation and movement (export) of capital, formation of an effective system of project financing, finance of investment and innovation processes, financial investment tools, financial strategy of corporations, securities market and foreign exchange market for insurance services, monetary system and monetary circulation mechanisms Credit relations, banks and other credit organizations, monetary regulation .

3. LABOR MARKET NEED FOR GRADUATES WHO HAVE COMPLETED THE POSTGRADUATE PROGRAM

When developing and implementing a postgraduate program in a scientific specialty 5.2.4 Finance, the educational organization (RUDN) focuses on a specific type of professional activity, namely specialists in the field of finance, workers in the financial sector of the Russian economy, university teachers, researchers in universities, research institutes, private companies. A postgraduate graduate receives basic training in economics and business communication; have an excellent command of new technologies in the field of finance. A graduate of graduate school is prepared based on the needs of the labor market, research and material and technical resources of the educational organization.

4. REQUIREMENTS FOR APPLICANTS APPLYING TO THE PROGRAM

Persons with an education of at least a higher education - a specialist's degree or a master's degree in economics - are allowed to master postgraduate programs for training scientific and pedagogical personnel. Admission to postgraduate programs for training scientific and pedagogical personnel is carried out on the principles of equal admission conditions for all applicants and is carried out on a competitive basis. Persons who are most capable and prepared to master postgraduate training programs for scientific and pedagogical personnel are enrolled in training. A potential EP applicant must have good knowledge of a foreign language; in the field of economics, finance; have practical experience in the financial sector of the economy.

Admission to postgraduate programs for training scientific and pedagogical personnel is carried out based on the results of entrance examinations. The entrance exam for the selected profile is carried out in the form of a computer test generated by the electronic examination support system (ESSE) using the method of randomly selecting tasks from a prepared bank of test items with ESSE automatically checking the correctness of completed tasks. The University takes into account the following individual achievements and evaluates them with the appropriate number of points for each achievement (for each monograph, article, diploma, report, etc. in the field corresponding to the group of scientific specialties within which the applicant participates in the competition).

5. STRUCTURE AND SCOPE OF THE GRADUATE PROGRAM

Duration of mastering the postgraduate program: 3/4 years.

Full-time form of education.

One credit unit corresponds to 36 academic hours.
