# 1. COURSE GOAL(s)

The goal of the c o u rPsivate International Law Issues in the Field of Transnational Insolvency» is to prepare students [seeking master's degree of law] to the perception and practical application of the basic rules of Transnational (cross-border) insolvency (bankruptcy).

### The objectives of the course are:
