6. INTERNSHIP EQUIPMENT AND TECHNOLOGY SUPPORT REQUIREMENTS

To conduct an introductory practice, classrooms equipped with individual computers for each student are required.

Means of ensuring the development of the introductory practice program: presentation materials, visual aids - a practice diary, analytical information systems, operating systems (Windows of the latest version); computer networks and software tools (Microsoft Office latest version) to solve applied problems that arise in the process of studying at the university and in the course of future professional activities.

7. INTERNSHIP LOCATION AND TIMELINE

"Introductory practice" can be carried out both in the structural units of the RUDN University or in the organizations of Moscow (stationary), and at bases located outside Moscow (visiting).

Conducting practice on the basis of an external organization (outside the RUDN University) is carried out on the basis of an appropriate contract, which specifies the terms, place and conditions of practice in the basic organization.

The terms of the internship correspond to the period specified in the calendar training schedule of the OP HE. The timing of the internship can be adjusted in coordination with the Department of Educational Policy and the Department of Practice Organization and Employment of Students at RUDN University.
