1. THE GOAL OF MASTERING DISCIPLINE

The discipline “EAEU in International Trade” is included in the master’s program “International Trade” in the direction of 04.38.01 “Economics” and is studied in the 2nd semester of the 1st year. The discipline is implemented by the Department of International Economic Relations.
