1. COURSE GOAL(s)

The discipline “Russian language and culture of speech” is included in the specialty program “General Medicine” in the direction of 31.05.01 “General Medicine” and is studied in the 1st semester of the 1st year. The discipline is implemented by the Department of Russian Language 5.
