### 1. COURSE GOAL(s)

The course is designed to contribute to the students' knowledge about state and law, about the main branches of law, as well as to form sustainable legal skills in the area of professional activity. The discipline "Law Science" is included in the "General Medicine" program in the field of studies 31.05.01 "General Medicine" and is studied in the 2nd semester of the 1st year. The discipline is implemented by the Department of Theory of Law and State. The discipline consists of 9 modules (sections) and 44 topics and is aimed at studying basic legal concepts and legal structures, relationships between legal phenomena.

The goal of mastering the discipline is to acquire basic knowledge by students about fundamentals of the theory of law and legislation of the Russian Federation, the principles of legal regulation of social relations, the fundamentals of state organization, as well as the legislative regulation of activities in the field of healthcare, the rights and responsibilities of medical workers, etc.
