1. EDUCATIONAL PROGRAMME GOAL (MISSION)

The main goal of the Higher Educational Programme is to development of students' personal qualities, as well as the formation of universal, general professional and professional competencies in accordance with the requirements of the RUDN in the field of training 40.04.01. "Jurisprudence" qualification "Master". Also, the purpose of Higher Educational Programme is the quality preparation of competitive and competent professionals with a high level of legal culture and legal awareness, fundamental knowledge in the field of law enforcement, counseling, research and teaching activities, demanded by the modern labor market, the state and society.

The mission of the Higher Educational Programme is to increase the degree of satisfaction of educational needs in the basics of application of international human rights law in international courts and quasi-judicial institutions, international organizations and bodies, in national courts, law enforcement agencies. As well as the formation of a comprehensive presentation of educational information on the basic institutions of international human rights law, including human rights protection in the UN system, the European system of human rights protection, international legal regulation of migration, the Inter-American system of human rights protection, the African system of human rights protection, human rights treaty bodies of the UN system, international humanitarian law, environmental human rights protection, and discrimination and gender issues in modern medicine

2. EDUCATIONAL PROGRAMME RELEVANCE, SPECIFICITY, AND UNIQUENESS

Level of higher education - Master's degree in the field of Higher Education 40.04.01 "Jurisprudence", profile - International Protection of Human Rights
Length of Educational Programme: 2 years (Full-time)

Profile Orientation.

The preparation of magister is focused on forming deep theoretical knowledge in the field of jurisprudence and preparing them to solve professional problems at a high level of proficiency.

The use of modules in the educational process and combining disciplines into blocks allows students to form a systematic understanding of the relationship between institutions and branches of law.

Using the comparative legal method in teaching law to students, their acquisition of the skills used to compare legal norms, institutions, principles, law enforcement practice, and other elements of legal cultures, allows to form a comprehensive vision of modern law.

Being taught in English allows them to study legal phenomena in the original language and helps students acquire the skills of legal argumentation and teaches them to draft legal documents in a foreign language.

During the education master`s study such disciplines as Philosophy of Law, History and Methodology of Legal Science, Comparative Law Research, International Law and Development, Foreign Language, Russian Language, Foreign Language for Legal Purposes, Russian Language for Legal Purposes, International Law: Issues of Migration and Asylum, Protection of Human Rights in the UN System, Human Rights Treaty Bodies, Environmental Protection and Human Rights, European System of Human Rights, African System of Human

Rights, The Right to Health in International Law, International Labour Rights in the Global Economy, Human Rights, SDGs and Challenges of the XXI Century, International Business and Human Rights, Discrimination and Gender Issues in Contemporary International Law, Inter-American System of Human Rights, Indigenous Peoples and Minorities Rights Protection, International Humanitarian Law.

More than 100 alumni graduated this master`s programme, there are from Afghanistan, Bahrain, Bangladesh, Bosnia and Herzegovina, Cambodia, Colombia, Cuba, Cyprus, Ecuador, France, Georgia, Ghana, Guinea, Iran, Iraq, Italy, Kazakhstan, Kyrgyzstan, Montenegro, Namibia, Nepal, Nigeria, Russia, Somalia, South Sudan, Spain, Sudan, Turkmenistan, UAE, Uzbekistan, Vietnam. Many graduates now work for intergovernmental organizations, NGOs, law firms, ministries and government agencies, universities, etc. It should be emphasized that in the course of their studies students keep up-to-date with the activities of human rights mechanisms provided by the UN social networks, OHCHR, UN web TV, etc. The program, supported by OHCHR in Moscow, regularly invites professors from the Universities of the Venice Consortium (EIUC) and human rights practitioners to deliver lecture modules on topics complementary to the courses conducted in the framework of the Master's program. Their lectures are held in the resource center. Among human rights practitioners, members of human rights treaty bodies and special procedures mandate holders visit the PFUR.

3. LABOUR MARKET NEEDS FOR PERSONNEL TRAINING IN EDUCATIONAL PROGRAMME PROFILE

The demand for graduates of the Higher Education Programme in the labour market is one of the most important indicators of its effectiveness; it is ensured through interaction with potential employers of graduates and consumers of their services at the regional and federal levels.

The knowledge and skills acquired as a result of successful completion of the program can be applied for employment in the UN system, specialized UN agencies, embassies, consulates, civil service, as well as by practicing lawyers, providing complaints of individuals under the special procedures of the UN Human Rights Council and the European Court of Human Rights, in human rights activities, for entering postgraduate studies, etc. Graduates of the program work successfully in the system of the Ministry of Foreign Affairs, international organizations, foreign relations agencies (embassies and consulates), etc.

5. SPECIAL REQUIREMENTS FOR POTENTIAL APPLICANTS

The admission test for Master's degree programs at the PFUR Law Institute is conducted in the form of a portfolio evaluation, in accordance with the procedure approved by the order of the Rector of the PFUR. The portfolio evaluation system is established in the program of admission tests.

A person who enters the educational programs for Master's degree of the Peoples' Friendship University of Russia Institute of Law, at the time of the entrance test must possess on the basis of basic higher education a system of special knowledge and the methodology of jurisprudence:

- methodology of revealing the meaning of state-legal phenomena and practical meaning of legal categories and constructions;
- skills of practical use of the obtained legal knowledge.

In the field of foreign language:

The content of the entrance test suggests that applicants with English language proficiency may receive additional points in the evaluation of the entrance test. This advantage may be obtained by the applicant who has confirmed the level of his knowledge documented in accordance with the requirements of the entrance test program.
