1. COURSE GOAL

The discipline "Political science" is included in the specialty program "Veterinary science" in the direction of 36.05.01 "Veterinary Medicine" and is studied in the 1st semester of the 1st year. The discipline is implemented by the Department of Public Policy and History of State and Law.
