## 1. COURSE GOAL:

The main goal of the course is to introduce students to the philological studies as of example of text studies. The discipline "Philology in the System of Modern Humanities" involves an integrative approach to the studies of text and modern philological research methods. Additionally, the discipline includes language studies based on systemic principle.

The course focuses on the specifics of language and text studies from the perspective of modern linguistic fields, such as linguo-semiotics, sociolinguistics, discourse analysis and cognitive linguistics. Based mainly on the works by modern philologists and linguists, it uncovers the mechanisms and strategies behind the text studies understanding language as a creative process and art.
